Students speak out for sensible gun laws

Students from Bangor, Hermon and Hampden High Schools gather in solidarity with the victims from the Marjory Stoneman Douglas High School shooting in Parkland, Florida. The week of March 14 Bangor High School students will join with students all across the country to honor the 17 Parkland students who were killed on Valentines' Day and to remember all students whose lives have been lost to senseless gun violence.

The students at John Bapst Memorial High School will walk out of our classrooms for 17 minutes to protest gun violence and raise awareness of our community's collective belief that schools need to be a safe place where children can learn and teachers can teach without fear. We say, "Enough is enough." Our government's inaction on the issue of gun violence is unacceptable and we will be relentless in our efforts until meaningful changes have been made to ensure our safety.

Students at Hermon High School will walk out of classes at 10 a.m. and gather in the gymnasium. For the next 17 minutes we will sign letters to Members of Congress, make phone calls to local legislators, and write condolence cards to families of victims. These letters will call for a change toward safer school environments, reform to gun laws, and real action on the issue of youth violence. We hope that by showing youth the power of their voices, they will continue to speak out. While our event will begin with a moment of silence, we show that we will be silent no longer. This age of ignoring the problem of gun violence ends with us.

Forced Migration from El Salvador

A PICA sister-city delegation focused on the issues of
forced migration recently returned from El Salvador.

Here's a glimpse of what we learned: The demographics of forced migration are changing. Emigration due to simple economic duress is now more the exception than the rule. Due to the epidemic of gang-related violence, thousands are fleeing not for their livelihoods but for their lives.

The origins of these gangs date back 30 years to the Salvadoran Civil War's displacement of youth to the poorest areas of Los Angeles. Threatened by the gangs they encountered, expatriated Salvadorans formed a gang of their own: the MS 13, or Mara Salvatrucha. Twenty years later, thousands of Salvadoran gang members were deported back to El Salvador. This virulent seed of organized violence landed on fertile ground: a post-war country with uprooted communities, weak and corrupt local governments, no safety net, and easy availability of weapons.

Today, large swaths of the population are threatened by the violent consequences of refusing gangs' extortion demands, caught in the crossfire between rival gangs, or simply in the wrong place at the wrong time. These conditions have caused widespread internal displacement, but in a small country there is often no place to hide from a gang's reach. Many of those threatened conclude they have no choice but to leave. The fastest growing profile of people apprehended at the border are unaccompanied children or parents with children asking for asylum. Refugees, not "illegals," are what they are. Human rights agencies concur that most of these émigrés have a credible fear of persecution as defined by international law.

Many Salvadorans with DACA or TPS may be at heightened risk of being extorted by gangs on their return. The dangers they would face are the very same that continue to impel forced migration to the U.S. The sooner those of us in the U.S. understand the changed realities currently impelling migration from Central America, the more effectively we can press for a just and humane immigration policy.

P&J Center awarded A.J. Muste Memorial Grant

We are pleased to announce that the P&J Center of Eastern Maine has been awarded a \$5,000 grant by the A.J. Muste Memorial Institute to be used for a project focused on centering racial justice in our movements and to allow us to bring together organizers working on diverse projects in the greater Bangor area for education and discussions to deepen our understanding of and commitment to racial justice. Amy Hughes, former Co-Coordinator, will be the Project Manager overseeing administration of the grant.

The A.J. Muste Memorial Institute, a national grantmaking organization based in New York City, was established by members of the War Resisters League to offer safe space to radical organizations threatened by government surveillance and harassment. Both a shelter and a hub, the Institute has grown into a nonprofit charitable foundation for innovative grassroots organizing across the nation and the globe. A.J. Muste was a central figure who helped introduce a young seminarian named Martin Luther King, Jr. to the notion of nonviolent activism. Muste was an indefatigable organizer who pioneered strategies for bringing together disparate groups to work in coalition. This is reflected in A.J. Muste Institute's support for diverse grassroots campaigns to oppose militarism, defend the environment, confront racism, and build social justice.

The grant from the A.J. Muste Social Justice Fund will help provide funds for a Peace and Justice Center organizer as well as stipends for two organizers of color to serve as consultants on the project. We look forward to holding our first meetings in the coming months and will keep our membership updated on community meetings and other ways to get involved. For more information on the A.J. State of Maine bows to corporate greed

This particularly corrupt form of corporate welfare includes details that many Maine state politicians seem insistent on ignoring. You should be opposed to L.D. 1781 if you are:

Do we have an opportunity for true unity, insistence on genuine representative government and an inclusive democracy, and a reversal of the clear movement toward an oligarchy? YES! Please join us in opposing L.D. 1781.

Excerpted from a Letter to the Editor published in the Portland Press Herald on March 14, 2018. As this newsletter goes to print: Bruce Gagnon is on day 34 of a hunger strike in protest. The Joint Standing Committee on Taxation has amended LD 1781 to give GD/BIW \$45 million over 15 years, so public outcry is having an effect.
